

ORDINANCE NO. 903

AN ORDINANCE RELATING TO
USER CHARGES IN THE
SKYLINE, VALLEY VIEW,
AND PRAIRIE PATH SERVICE
AREA

WHEREAS, the Fox River Water Reclamation District ("District") established the Skyline, Valley View, and Prairie Path ("SVP") Service Area by Ordinance No. 602, and;

WHEREAS, the District adopted certain regulations and fees with respect to sewer and water service pursuant to Ordinance No. 647, and;

WHEREAS, the SVP Service Area was annexed to the District by Ordinance No. 824 on January 10, 2011 and therefor sewage treatment User Charges are determined by Ordinance No. 313 as amended from time to time;

WHEREAS, the District finds that it is necessary and in the best interests of the District to amend the user charges set forth in Section II of Ordinance No. 647;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE FOX RIVER WATER RECLAMATION DISTRICT, KANE AND COOK COUNTIES, ILLINOIS:

SECTION I: That the water and sewer service user charge rates established in Ordinance No. 602 and as amended by Ordinance No. 647 Section II (A) and Section II (B) shall be amended by this Ordinance as stated herein. The User Charge rates for sewage treatment shall be determined by Ordinance 313 as amended from time to time, including without limitation Ordinance 884 and Ordinance 902.

SECTION II: From and after July 1, 2018, or until such time as rescinded by amendment of this ordinance, the SVP Service Area User Charge rates shall be as listed in the following table:

A. WATER SERVICE

B. SEWER SERVICE:

1. Until such time as rescinded by amendment of this ordinance, the User Charge rate henceforth from the effective date of this Ordinance shall be as listed in the following table:
