

ORDINANCE NO. 914

AN ORDINANCE AMENDING  
ORDINANCE NO. 313 OF THE  
FOX RIVER WATER RECLAMATION  
DISTRICT ENTITLED A USER  
CHARGE RATE ORDINANCE

WHEREAS, the Board of Trustees of the FOX RIVER WATER RECLAMATION DISTRICT has determined that it is in the best interest of the District to establish a user charge pursuant to Section 12 of Ordinance No. 317 passed July 14, 1975;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE FOX RIVER WATER RECLAMATION DISTRICT OF KANE AND COOK COUNTIES, ILLINOIS:

SECTION ONE: Effective on and after July 1, 2019, Section 1 of Ordinance 313 entitled User Charge Rate Ordinance, be and hereby is amended to read as follows:

Section 1. Rates

A. Until such time as rescinded by amendment of this ordinance, the User Charge rate henceforth from the effective date of this Ordinance shall be as listed in the following table:

User Classification:

Residential:

Residential User	\$3.25 per 1000 gallons of metered water use (\$2.44 per 100 cubic feet of metered water use).
Residential Private Well User	\$27.00 per month per unit, where approved, see Paragraph C. below.

Governmental/Institutional:

Governmental/Institutional	\$3.40 per 1000 gallons of metered water use (\$2.55 per 100 cubic feet of metered water use).
Governmental/Institutional Private Well User	\$28.70 per month, where approved, see Paragraph C. below.

Commercial:

Commercial User	\$3.54 per 1000 gallons of metered water use (\$2.64 per 100 cubic feet of metered water use).
Commercial Private Well User	\$28.70 per month, where approved, see Paragraph C. below.

Industrial:

Industrial User	\$4.38 per 1000 gallons of wastes discharged (\$3.25 per 100 cubic feet of wastes discharged).
Industrial Private Well User	\$28.70 per month, where approved, see Paragraph C. below.
User Charge for excessive BOD (BOD <sub>5</sub> ) (>200 mg/l)	\$0.65 per pound discharged >200 mg/l.
User Charge for excessive Suspended Solids (SS) (>250 mg/l)	\$0.50 per pound discharged >250mg/l.
User Charge for excessive Ammonia (NH <sub>3</sub> ) (>30 mg/l)	\$8.37 per pound >30 mg/l.
User Charge for excessive Kjeldahl Nitrogen (TKN) (>30 mg/l)	\$8.37 per pound >30 mg/l.

B. Any non-Residential User that has a metered discharge may pay the applicable User Charge rate based on the metered waste discharged, upon prior approval of the Executive Director. Any User without an approved discharge meter will pay user charges based on metered water use. Discharge meters are not permitted for Residential Users without prior approval by the District Board of Trustees. The Industrial User Charge for excessive BOD<sub>5</sub>, SS, NH<sub>3</sub> and TKN shall be calculated using average waste strength and the volume of waste discharged, as approved by the Executive Director, in excess of the stated concentration.

C. A non-Residential Private Well User shall install a metered discharge in a manner to be approved by the Executive Director. A Private Well User may pay a monthly flat rate only when approved by the District's Executive Director.

SECTION III: Any ordinance or any part of an ordinance in conflict herewith is hereby repealed.

SECTION IV: That this ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
