

**ADVERTISEMENT FOR BIDS**

PART 1 GENERAL

1.1 Receipt of Bids

- A. Sealed proposals will be received by the Fox River Water Reclamation District for the project entitled “Pump Station 38 Improvements” until 2:00 PM April 6, 2022 at the Office of the Fox River Water Reclamation District (FRWRD), 1957 North LaFox Street, South Elgin, IL 60177. The sealed bids will be publicly opened and read aloud at the FRWRD Offices immediately afterwards. Sealed bids shall be addressed to the Fox River Water Reclamation District (FRWRD) 1957 North LaFox Street, South Elgin, IL 60177 and shall be labeled “Bid for Pump Station 38 Improvements.”
- B. Bidders will be required to comply with the President's Executive Order No. 11246, as amended. The requirements for bidders and contractors under this order are explained in 41 CFR 60-4.

1.2 Work Description

A. Lift Station Rehabilitation

- 1. Provide all equipment, labor and appurtenances required to rehabilitate the Pump Station 38 including grinder, motor control center, bar screen, flow meter, radar level measurement, FRP roof panels and framing, flood barriers, structural revisions, retrofit safety grate, pre-cast bypass vaults, piping modifications, and ventilation, electrical and control system modifications.
- 2. Bypass pumping will be required a portion of the construction duration.

- B. The successful bidder will be required to furnish Performance and Payment Bonds on forms provided in the Specifications and Contract Documents, each in an amount equal to 100 percent of the contract price.
